

**Minutes of a Regular Meeting of the Board of Trustees
Aspermont Independent School District
August 28, 2025**

At a regular meeting of the Aspermont Independent School District Board of Trustees held on August 28, 2025, members Ray Bradley, Lorenzo Calamaco, Jennifer Hodges, Tres Myers, Brandon Criswell. and Superintendent Zach Morris. Bay Hecht, Shane Polk, and Ray Bradley were absent. Also in attendance were Jerry, Adalee, Kristin, Hollis, Briggs Marsh and Angela Moya, Allison and Willis Martin, Emily McLaury, Alexis Gaspar, Tiffany Potts, and Jenna.

President Lorenzo Calamaco called the meeting to order at 6:30 p.m.

Superintendent Morris led the invocation followed by Lorenzo Calamaco leading the pledges.

No one addressed the board in an open forum.

No one addressed the board on the 2025/2026 Budget and Tax Hearing.

Mrs. Gaspar presented the elementary student of the month award to Hollis Marsh. Hollis was recognized for being engaged, looking out for others and always working.

Mrs. McLaury was awarded the elementary teacher of the month award. She was praised on doing whatever it takes to help students succeed and making sure each student felt loved.

Tres Myers made a motion to approve the adult meal prices as \$3.40 for breakfast and \$5.20 for lunch. Jennifer Hodges seconded the motion. All trustees voted in favor.

Brandon Criswell then made a motion to approve the update to the 25-26 faculty handbook on the tattoo policy. Jennifer Hodges seconded the motion. All were in favor.

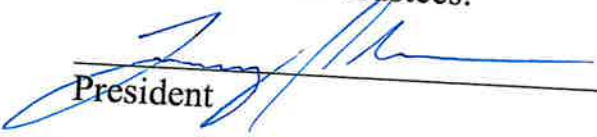
