

**Minutes of a Regular Meeting of the Board of Trustees
Aspermont Independent School District
June 16, 2025**

At a regular meeting of the Aspermont Independent School District Board of Trustees held on June 16, 2025, members Bay Hecht, Lorenzo Calamaco, Brandon Criswell, Tres Myers, Shane Polk and Superintendent Zach Morris. Jennifer Hodges and Ray Bradley were absent. Also in attendance were Alexis Gaspar and Jeff Hurt.

President Lorenzo Calamaco called the meeting to order at 6:33 p.m.

Superintendent Morris led the invocation followed by Lorenzo Calamaco leading the pledges.

No one addressed the board in an open forum.

After reviewing the consent items, Tres Myers made a motion to approve the minutes from the previous meetings held on May 21, 2025 and May 28, 2025. Brandon Criswell seconded the motion. All were in favor.

Brandon Criwell made a motion to approve bills payable from the middle of May through the current date in June. Bay Hecht seconded the motion. Motion passed unanimously.

The Trustees reviewed and discussed the Memorandum of Understanding between the Aspermont ISD Education Foundation and Aspermont Independent School District. Shane Polk motioned to approve the MOU. Tres Myers seconded the motion. All trustees were in favor.

The board spoke briefly about SB 401 homeschool participation in athletics at AISD. Brandon Criswell made the motion to adopt a policy that states homeschool students will not be allowed to participate in UIL activities at AISD. Shane Polk seconded the motion. All trustees were in favor of the motion.

Next, Tres Myers made a motion to approve the Edgin, Parkmann, Fleming, Fleming Nepotism & Pecuniary Interest letter. Bay Hecht seconded the motion. Motion carried unanimously.

Bay Hecht then motioned to approve the TASB policy update 125. Tres Myers seconded the motion. The motion carried with a 5-0 vote.

After review, Brandon Criswell made a motion to approve the budget amendment #1 as presented. Tres Myers seconded the motion. All were in favor.

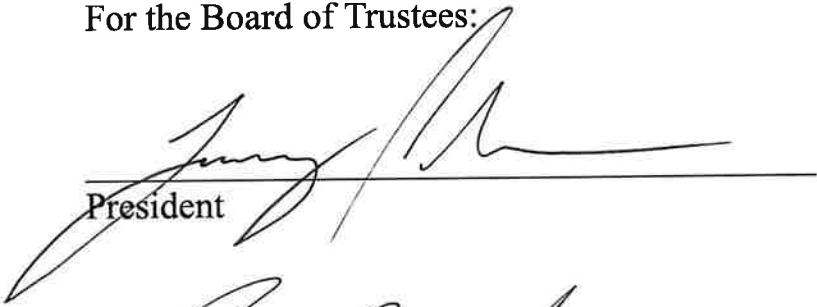
