

**Minutes of a Regular Meeting of the Board of Trustees

May 21, 2025**

At a regular meeting of the Aspermont Independent School District Board of Trustees held on May 21, 2025, members Tres Myers, Jennifer Hodges, Lorenzo Calamaco, Brandon Criswell, Shane Polk and Superintendent Zach Morris. Bay Hecht and Ray Bradley were absent. Also in attendance were Tiffany Potts, Greg Decker, Alexis Gaspar, and Kristin Marsh.

President Lorenzo Calamaco called the meeting to order at 6:30 p.m.

Superintendent Morris led the invocation followed by Lorenzo Calamaco leading the pledges.

No one addressed the board in an open forum.

A couple of line items may need to be amended before the close of the books. Investment report looks good as most of the taxes for the year have been collected. The end of year staff luncheon will be held on Friday May 23rd at 11 am with graduation following at 8 pm.
