Brandon Criswell made a motion to approve the adoption of 2020-2021 AISD Budget for Fund 199. Lorenzo Calamaco seconded, and motion carried unanimously.

Following, Ray Bradley made a motion to adopt the 2020-2021 AISD Budget for Fund 240. Motion was seconded by Lorenzo Calamaco and passed unanimously.

Bay Hecht made a motion to adopt the 2020-2021 AISD Budget for Fund 599. Motion was seconded by Ray Bradley. All were in favor.

Next the Board approved a Resolution setting the 2020-2021 Proposed Tax Rates. Bay Hecht made a motion to approve the M&O rate of \$.9664, Lorenzo Calamaco seconded. Motion passed. Bay Hecht then made a motion to approve the I&S rate of \$.3796. Lorenzo Calamaco seconded the motion and all were for.

Lorenzo Calamaco made a motion to approve the Interlocal Agreement with West Texas Food Service Cooperative. Brandon Criswell seconded the motion and motion passed.

Elementary Principal Trent Van Meter gave a positive report of the first weeks of school. He addressed attendance, distant learning, theme, and the testing that is underway.

Secondary Principal Ronnie Garcia then addressed the Board also on attendance and distant learning in the secondary. He spoke on athletics, 2Words Character Program, and his overall satisfaction of the first weeks of school.
